Professor R. Mirzazadeh writes that there a lot of men who has not still separated from patriarchal stereotypes and they consider the gender problem as a woman's ambition. They do not realistically assess how much women's participation in all spheres as a counterpart to men will benefit society, how easy it will be to solve social problems, and their role in conflict prevention and resolution. While some men consider it normal for women to work as teachers and doctors, they cannot accept them as school principals or chief doctors. This is due to the fact that the woman in office pays less attention to home and family, spends less time. Men try to prove that the majority of women in office do their homework in a planned and decent way compared to housewives. There are some men who sincerely understand the problem and want to eliminate it (Mirzazade, 2004).

In a stable society, it is normal for a family to make developments and its economic situation changes regularly. It depends on the demographic factors and events in the life of the family that change its status in one way or another (age to get married, birth of children, their employment and income, professional development, retirement, etc.).

The joint activities of parents in preschools and schools periods, as well as the interaction of parents with each other has an exceptional importance in the upbringing of children (Mirzayev, 2005). Thus, mutual understanding between parents, their respect for each other has a positive effect on the upbringing of children in the family. If in the family the father and mother treat each other with respect, they try to solve each problem together, the child also will try to be like his parents when he becomes a parent in the future. Therefore, in order for the next generation to grow up spiritually and physically healthy, parents must set a good example for their children in the family.
